Subject: Manila Bay IIMS Integration Workshop, August 22-24 and September 25-27, 2012, PEMSEA Office, Quezon City

1. A two-stage integration workshop was conducted on August 22-24 and September 25-27, 2012 at the PEMSEA Office Bldg to establish an integrated IIMS database for the Manila Bay watershed, including the 3 DENR SMOs (Regions 3, 4a and NCR) and two ICM sites (Bataan and Cavite) in the area. The list of participants for the integration workshop is given in Annex 1.

2. The objectives for the two-stage integration workshops are as follows.

i. Workshop 1 (August 22-24)

- To conduct the integration workshop for the Manila Bay IIMS, particularly focusing on
 - Assigning unique record numbers (geocode) for each table of the IIMS, and
 - Reclassifying the records based on the new values of the dropdown menus.
- Develop a work plan and agree on the timetable for the integration of the databases of the 3 SMOs and 2 provinces in addition to the old Manila Bay database.

ii. Workshop 2 (September 25-27)

- To establish an integrated Manila Bay IIMS databases, with server located at the PRF, particularly focusing on:
 - Importing of renumbered and adjusted records into the IIMS server;
 - Resolving any issues on redundancy; and
- Action plan on the maintenance and updating of the IIMS databases in the Manila Bay area regions

3. The detailed workshop programme for the integration of the IIMS database for the Manila Bay watershed is given in Annexes 2 and 3.

4. Some of the observed areas of difficulties in establishing the integrated database for the Manila Bay watershed are as follows.

- Renumbering of records. In order to assign unique record numbers for each of the data entries in the IIMS and to facilitate integration of the separate IIMS databases for Manila Bay, a standard numbering of record is designed following the Philippine Geographic Codes. The geocodes provide a unique coding for each of the barangays, municipalities and provinces in the Philippines. Although the numbering

is not difficult, it is tedious and participant should be familiar with the new coding system, including table linkages. The guide for numbering records and the establishment of integrated database for the Manila Bay watershed is given in Annex 4.

- Reclassification of industries and commercial establishments. The current IIMS version for the Philippines follows the Philippine Standard Industry Classification (PSIC), which is a detailed classification of industries and establishments compared to the International Standard Industry Classification, which was adopted in the previous IIMS version. The difficulty encountered by the participants was that some of the entries had general classifications, and participants need to review their original data (e.g., Bataan) to determine the specific classifications of data records. For the case of NCR, they have almost 10,000 data records for industries that need to be reclassified.

5. The process of renumbering data records for each of the data category in the IIMS was discussed and it was agreed that participants will continue the process of renumbering the data encoded in their current IIMS database, until all records have been renumbered and imported into the IIMS server.

6. The importing of data into the IIMS server was conducted one month after the first workshop to allow the participants to renumber their respective data records.

7. The importing of data records into the IIMS server was done per region (Annex 3) using the import facility of the IIMS connected through a Local Area Network. All renumbered records have been imported into the IIMS server. The counts of data records imported in the IIMS server are given in Annex 5.

8. Not all data of the regions and ICM sites in Manila Bay have been renumbered and imported into the IIMS server. Some renumbered records had been forwarded to the regions for review due to duplication errors. The regions still need to work on the reclassification of the commercial establishments (e.g., Bataan, Regions 3 and 4a), renumbering of pollution sources data (NCR) and review of record numbering (Region 4a).

Action: The TA for Project Development will follow up with the DENR regions and ICM sites for the completion of the remaining records for renumbering, classification and importing into the IIMS server.

Annex 2.

Workshops on the Integration of the Manila Bay Area IIMS Database

Introduction

There are five separate IIMS databases within the Manila Bay Area that have been established and maintained by the three Site Management Offices at the three regional offices of DENR and two ICM sites in Bataan and Cavite. At the moment, access of these databases requires going through each of the sites' databases, which requires more time and effort as compared if they are integrated into a single database. The redundancies and inconsistencies, if any, of these databases have not resolved. In order to make these databases accessible and useful for the whole Manila Bay Area, integration of the five databases is necessary.

The workshop aims to integrate the five databases into a single Manila Bay area database. Specifically, it will aim the following:

- 1) renumber the records of each of the five databases to ensure consistencies and reduce redundancies of the records when they are integrated into one database;
- 2) integrate the old database that was developed from 2002 to 2007 into the existing databases of the sites;
- 3) set-up an IIMS server at PRF where the integrated database will be stored and maintained; and
- 2) identify areas of difficulties and possible solutions, if any, in maintaining the database resulting from the integration process

Participant

The participants of the workshop will be those who have been developing and maintaining the various IIMS database from each site. There will be two participants from each regional offices and ICM site.

Approach

The workshop will be undertaken in two stages. The first one will be a three-day workshop, which aim to renumber and adjust of the records of the existing and old databases. The second workshop will be the setting-up of an IIMS server at the PRF and integrating all the five databases into the server. The second workshop will entail each of the sites to work for a day at PRF in order to import data into the server and resolve redundancy issues, if any.

The specific approaches of renumbering and integration will be provided to the participants.

Output

The outputs of the workshops will be:

- 1) Renumbered records of the IIMS databases of the sites (existing and old); and
- 2) Integrated IIMS database established at PRF.

Annex 4

GUIDE TO THE INTEGRATION OF MANILA BAY AREA IIMS DATABASE

Integrating the five databases from the three SMOs and two ICM sites, and the old Manila Bay database entails setting of common dropdown menus, data aggregation, and assigning unique record numbers for each table.

Assigning unique record numbers

In order to avoid duplication of values and committing key violation errors when integrating the databases, there is a need to assign unique values for each record in each table. For provinces, municipalities and barangays, it was agreed during the workshop in September 2011 that the geocode (see Geocode in CD) will be used as record numbers. Numbers of the records in other tables should also follow that system.

The geocode consists of the following:

- First 2 digits (including zero) – region
- Next 2 digits- province/district for NCR
- Next 2 digits – municipality/city
- Next 3-digits -barangay

If the data aggregation is at the barangay level like census, the record number is :Geocode + record no. Record number may start at 1.

Example: Record number of census in Barangay 1, Caloocan

- First record – 137501001+1>> 1375010011
- Second record – 137501001+2>> 1375010012
- 10th record – 137501001+10>> 13750100110
- 100th record – 137501001+100>> 137501001100

This means that consecutive numbering of records starts after the barangay geocode.

If the data aggregation is at the municipal level, the record number would be the first six digits of geocode of the municipality+ record number.

Example: 137501 +1

- 1st – 137501+1>> 1375011
- 2nd record – 137501+2>> 1375012
- 3rd record – 137501+3>> 1375013
- 10th record – 137501+10>> 13750110
- 100th record- 137501>> 137501100

Consecutive numbering of records starts after the first six digits of the geocode.

If the data aggregation is at provincial level, the record number would be first 4 digits of the geocode+ record number.

Example: Record number of poverty incidence of Bataan

- 1st record – 0308+1>>03081 or 3081
- 2nd record – 0308+2>>03082 or 3082

- 10th record- 0308+10>>030810 or 30810
- 100th record-0308+100>>0308100 Or 308100

For subwatershed and bodies of water, follow the provincial numbering.

Example:

Watershed: Pampanga River Basin
 Subwatershed: Gumain River Basin: 0354+1>>3451
 Pampanga River: 0354+1>>3451.

Please do not be confused by the same record numbers of Gumain River Basin and Pampanga River to cause key violation error because these two records would not be encoded on the same table.

For Manila Bay, assign a record number following the region code, which is 13 + record: 13+1>>201

If the data aggregation is at site level, use the same system as that of the province. This will facilitate integration and avoid confusion as to the linkages of data of a certain table to its parent table.

Biological data

Most of the species in the database of the regions are common in each region. In order to avoid key violation error, we use only one numbering system. The species shall be numbered consecutively using the scientific name in alphabetical order regardless of region. The numbering shall follow site number for Philippines which starts at 200001:

Example:

- 1st record: 20000+1=200001
- 2nd record: 20000+2=200002
- 10th record: 20000+10=200010
- 100th record: 20000+100=200100

If adding a new species, check first if that species has been encoded into the database by other regions. The list of renumbered species for fish, aquaculture species, mangrove, forest, flora and fauna are contained in CD.

Governance data

Government agencies

For national government, the agencies shall be numbered consecutively starting with 200001. The local government agencies shall be numbered based on the geocode of the province, municipality/city and barangay concerned.

Examples:

Pampanga

- 1st record: 0354+1>>3541
- 2nd record: 0354+2>>3542

- 10th record: 0354=35410
- 100TH record=3454100

Lubao, Pampanga

- 1st record: 035408+1>>354081
- 2nd record: 035408+2>>354082
- 10th record: 035408+10>>3540810
- 100th record: 035408+100>>35408100

Balantacan, Lubao, Pampanga

- 1st record: 035408001+1>>354080011
- 2nd record: 035408001+2>>354080012
- 10th record: 035408001+10>>3540800110
- 100th record: 035408001+100>>35408001100

All records linked to the government agencies (GOVAG) shall follow the numbering of the agency.

Example:

Projects

Pampanga: 1st agency

- 1st project: 3541+1>>35411
- 2nd project: 3541+2>>35412
- 10th project: 3541+10>>35410
- 100th project: 3541+100>>354100

For coordinating mechanisms and plans, the numbering shall be based on the level of government, like the numbering for government agencies.

Sector

The numbering shall be based on the province of the office of the sector.

Example:

Pampanga

- 1st record: 0354+1>>3541
- 2nd record: 0354+2>>3542
- 10th record: 0354>>35410
- 100TH record>>354100

Water resources

Infrastructure

The numbering shall be based on the municipality/city where the infrastructure is located.

Example:

Lubao, Pampanga

- 1st infrastructure: 035408+1>>354081
- 2nd infrastructure: 035408+2>>354082
- 10th infrastructure: 035408+10>>3540810
- 100th infrastructure: 035408+100>>35408100

For water distributor, the numbering shall be based on the municipality or city of the address of the water distributor. Thus, the numbering is of the same format as that of Infrastructure.

The water user permit table is linked with water distributor. It's numbering should be based on the water distributor number.

Example:

- 1st water user: 354081+1>>3540811
- 2nd water user: 354081+2>>3540812
- 10th water user: 354081+10>>35408110
- 100th water user: 354081+100>>354081100

All other tables included in the Water Resources Category shall follow the municipality/city numbers.

Environmental Quality Monitoring Data

The record identifier for monitoring station is Station ID, there is no need for a new number. The records (WQOBS, SQOBS, TAOBS) that are linked to station shall be numbered consecutively following the number of water body.

Example: Manila Bay (13)

- 1st observation: 13+1>>131
- 2nd observation: 13+2>>132
- 10th observation: 13+10>>1310
- 100th observation: 131+100>>13100

All records linked with observation shall be numbered based on the observation number by appending the record number consecutively.

Example: 1st Observation (131)

1st record: 131+1>>1311

2nd record: 131+2>>1312

10th record: 131+10>>13110

100th record: 131+100>>131100

All records linked with Observation shall be numbered based on the observation number.

Example:

Conventional parameters for observation 1311

1st record: 1311+1>>13111

2nd record: 1311+2>>13112

10th record: 1311+10>>131110
100th record: 1311+100>>1311100

For criteria/standard, use the numbering for national values like that of species numbering for biological data basing on site number. See renumbered tables.

Example:

1st record: 200+1>>2001
2nd record: 200+2>>2002
10th record: 200+10>>20010
100th record: 200+100>>200100

For Natural and Cultural Heritage Data, base the numbering from province number.

Example: For sites within Bulacan (PROTNH and PROTCH)

1st record: 0314+1>>3141
2nd record: 0314+2>>3142
10th record: 031410>>31410
100th record: 0314+100>>314100

For tables linked with PROTNH and PROTCH, base the numbering from the record numbers of PROTNH and PROTCH.

Example: 1st record of PROTNH: 3141

1st record: 3141+ 1>>31411
2nd record: 3141+2>>31412
10th record: 3141+10>>314110
100th record: 3141+100>>3141100

Dropdown menu

Dropdown menu with values used in the Philippines have been adopted for IIMS particularly on the following:

- a) Mining establishment type for table SEMINE
- b) Industry type for table SEMINEPR
- c) Manufacturing type for table SEIND
- d) Establishment type for SECOMMES
- e) Type of service provided for SEMJRINS
- f) Waste type for POLHWSV
- g) ISIC Type for POLHW
- h) Waste type for POLSW
- i) Hazard type for HAZARDS and HAZARDAR

Existing data encoded into the abovementioned tables need to be reclassified based on the new dropdown menu. Appendix 1 can be used as a guide in reclassifying data. It bears the previous classifications based on the default dropdown values of IIMS and the corresponding new classifications. It is also important to use the raw data (unclassified and unscreened) to determine appropriate classifications of the records/data.

As renumbering of records is being undertaken, reclassifying of records based in the new dropdown menu should be done. Take note that classification not included in the dropdown values could not be displayed in the tables. Make sure that the values being encoded are consistent with the dropdown values.

Importing records into the IIMS server

All .csv files, which was renumbered and reclassified during the three-day workshop will be imported into an IIMS server set-up at PEMSEA Resource Facility. The IIMS_BLANK.GDB will be renamed into IIMS_MBA.GDB, and will be installed into the server. Each of the regions and site will be allotted a day to import their data into the server.

Once the database has been integrated, it will be provided to the SMOs and ICM sites for updating. The numbering system of records shall be followed. New data from the regions and sites shall be provided to PRF, which will maintain and update the Manila Bay Area database until such time that it will be turned over to DENR or appropriate unit.
