

REPORT ON THE MEETING WITH UNDERSECRETARY JOEL RUDINAS AND STAFF

July 26, 2012

Office of the Undersecretary for Field Operations
Department of Agriculture

1. A meeting with Undersecretary Joel Rudinas of the Department of Agriculture was convened to discuss their Department's possible participation and contribution to the development of a nutrient management strategy for the Manila Bay region (i.e. point and non-point sources of nutrients) including compilation of best practices in nutrient management under the UNEP/GEF Project.
 2. The agenda and the list of participants to the meeting are shown in Annex 1 and Annex 2, respectively.
 3. The highlights of the meeting, including required actions are shown below:
 - i) The Department of Agriculture, as part of its compliance to the Supreme Court Continuing Mandamus for the Manila Bay has established a Manila Bay Task Force which will be tapped in its commitment to cooperate and participate in the implementation of the UNEP/GEF Global Foundations for reducing Nutrient Enrichment and Oxygen Depletion from Land-based Pollution in support of Global Nutrient Cycle. The arrangement for cooperation and participation will be through a Memorandum of Understanding (MOU).
- Action to be taken: PEMSEA to provide the draft MOU between the Department of Agriculture, UP Marine Science Institute and PEMSEA.***
- ii) The UP Marine Science Institute is willing to provide technical advice on-going initiative to estimate pollution loading from agricultural sector.
 - iii) PEMSEA will provide access to all information it has its holding to the Department of Agriculture, including providing access to available partners in its implementation of pollution monitoring from agriculture such as fertilizer utilization, water quality monitoring of aquaculture areas, database management and mapping.
 4. Undersecretary Rudinas express gratitude to Mr. Adrian Ross for sharing the work done by PEMSEA, especially in engaging the Department of Agriculture in the UNEP/GEF Nutrient Management.
